## WRITING PRODUCER AGREEMENT

This Writing Producer Agreement amends the Ohio Insurance Producer Agreement (the "Producer Agreement") among Medical Mutual of Ohio<sup>®</sup> ("Medical Mutual"), \_\_\_\_\_ (the "Agency"), and \_\_\_\_\_ (the "Writing Producer") and applies to the business indicated below (the "Business"). (Please check only one box.)

- Individual business and business for groups with 1-50 eligible employees
- Individual business and business for groups with 1-99 eligible employees
- All business

### RECITALS

- A. The Agency and the Writing Producer have previously entered into a Producer Agreement with Medical Mutual.
- B. The parties wish to modify the manner in which commission payments are made to the Writing Producer under the Producer Agreement.

Now, therefore, in consideration of the mutual promises contained herein, the parties agree as follows.

### PROVISIONS

1. The Writing Producer hereby assigns to the Agency the Writing Producer's right to commission payments for the Business. For commissions on existing Business, this assignment shall be effective as of the renewal date of such existing business, or if a block transfer of such existing business has been made this assignment shall be effective on the effective date of such block transfer. For commissions on new Business, this assignment shall be effective on the effective date of such new business.
2. The Writing Producer acknowledges that after the effective date of this Writing Producer Agreement, the Writing Producer will no longer be paid directly by Medical Mutual for commissions earned on the Business, except as provided in Section 5.
3. The Agency hereby agrees to pay the Writing Producer on behalf of Medical Mutual as provided in the Producer Agreement.

4. Any party may terminate this agreement upon thirty (30) days prior written notice.
5. If this Agreement is terminated pursuant to Section 4, Medical Mutual shall resume making all commission payments for the Business directly to the Writing Producer until the Writing Producer signs a new Writing Producer Agreement with another eligible agency. Upon termination of this Agreement, the Agency is entitled to receive override commissions earned on the Business written by the Writing Producer up to the effective date of termination of this Agreement.
6. If this agreement is terminated, the Writing Producer must enter into a new Writing Producer Agreement for its individual business and business for groups with 1-50 eligible employees with an eligible Agency from a list provided by Medical Mutual within thirty (30) days of the date of termination.
7. Except as specifically contained in this Agreement, all terms of the Producer Agreement between Medical Mutual and the Agency and between Medical Mutual and the Writing Producer remain in full force and effect.
8. The Effective Date of this Writing Producer Agreement shall be the date it is signed by the Writing Producer.
